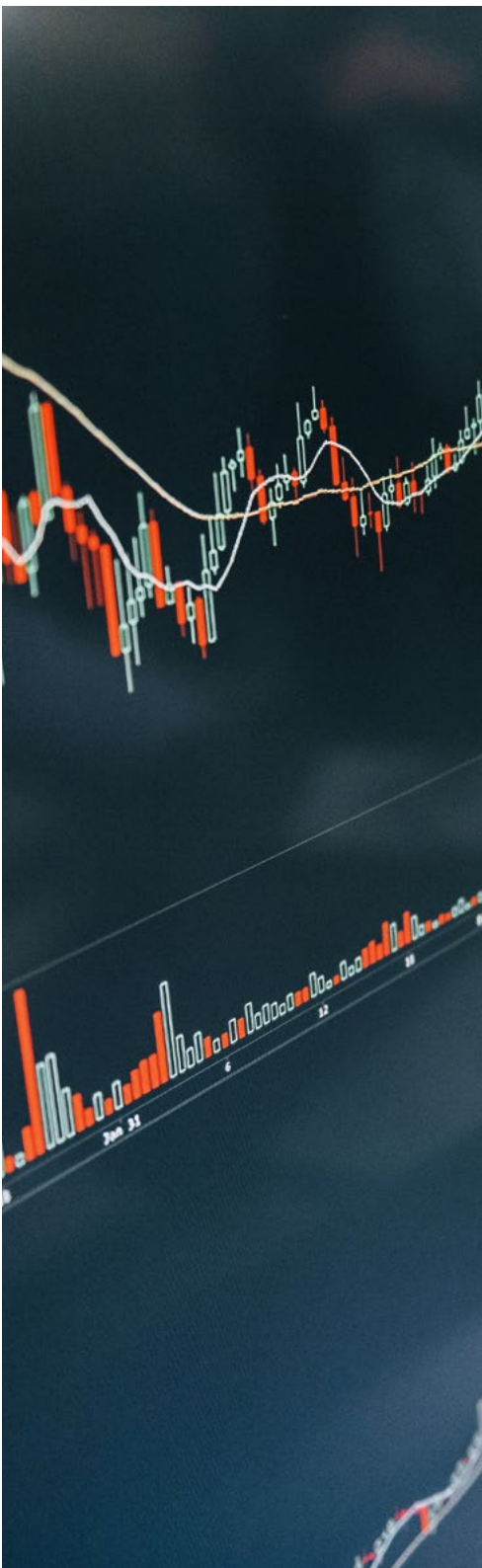

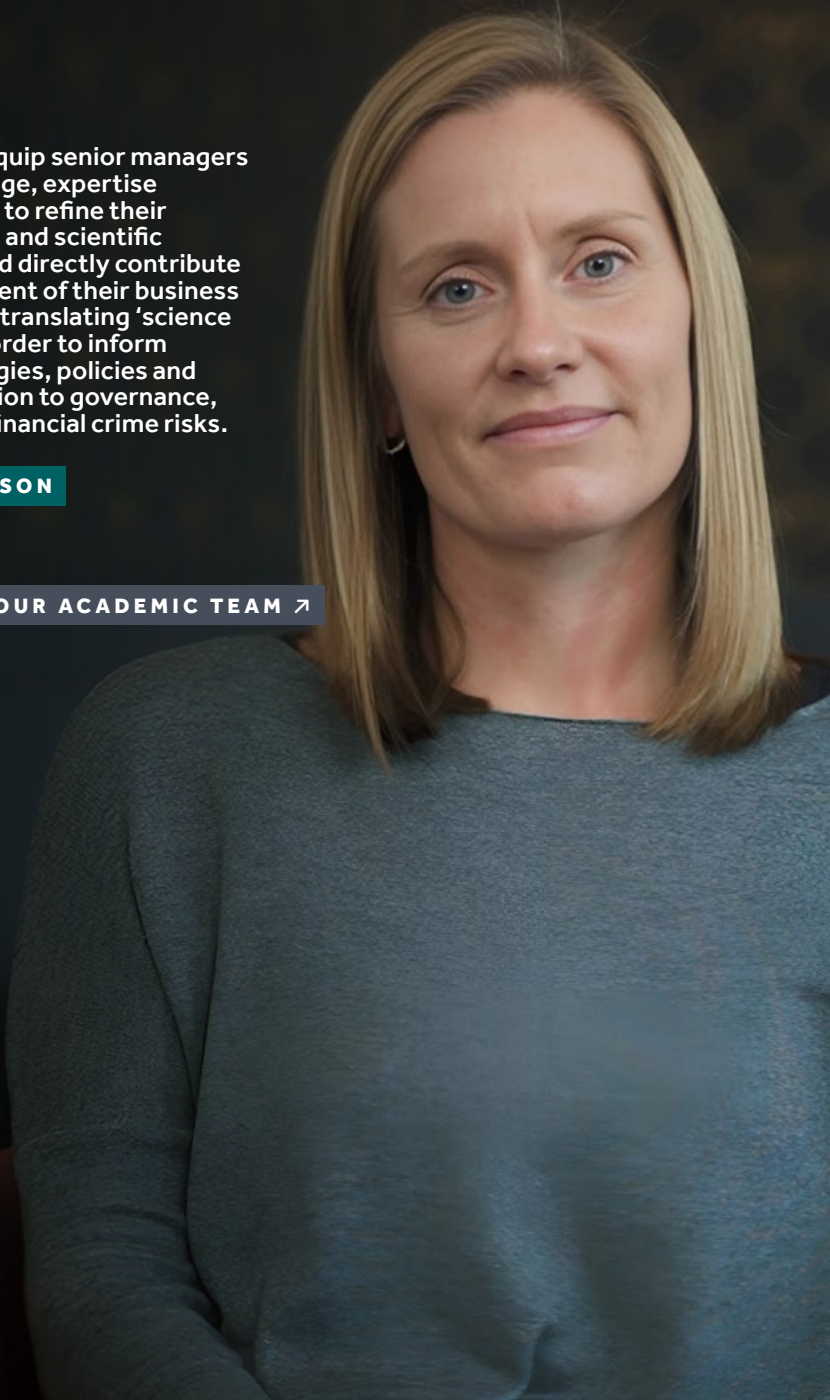

# COMPLIANCE AND FINANCIAL CRIME RISKS – ANALYSIS AND EXPLANATION (20 CREDITS)

## ABOUT THIS UNIT

**This unit provides an advanced introduction to the theoretical and analytical frameworks used to understand compliance and financial crime risks within businesses.**

You'll explore how individual motivations, organisational structures, and broader political-economic environments contribute to non-compliance and financial crime. Through case studies and conceptual analysis, you'll examine how and why opportunities for misconduct arise, how transgressions are concealed, and what strategies could prevent them.

The unit equips you with a multi-level theoretical toolkit to assess risks, understand regulatory responses, and inform policy and practice aimed at making organisations more robust, efficient, and compliant.

Topics include individual and organisational risk factors, modes of analysis such as scripting and network approaches, and case studies on globalised economies, anti-money laundering, and modern slavery.

## LEARNING OUTCOMES

- + Possess a theoretical and conceptual toolkit for explaining risk, threats, and transgressions in business contexts.
- + Recognise the complexity of regulatory and governance challenges in modern organisations.
- + Integrate theory with professional experience to inform strategy and operational policy.
- + Understand how to interact with regulators and enforcement authorities, including information sharing and self-reporting.

## ABOUT THIS UNIT

**This unit explores the intersection of digital technologies and financial crime, equipping you with the knowledge to navigate both the opportunities and risks that digital transformation brings to business compliance.**

You'll examine how digital systems can support regulatory change and enhance business efficiency, while also understanding the vulnerabilities they introduce.

The unit covers key topics such as digital trust, cybersecurity, misinformation, and the governance challenges posed by emerging technologies like FinTech, RegTech, and cryptocurrencies. You'll also explore cyber-enabled financial crimes—including money laundering, corruption, and illicit finance—and how businesses can respond strategically.

Through a blend of theoretical insight and practical application, this unit prepares you to integrate digital awareness into compliance strategies and policy development.

- + Possess advanced knowledge of business risks and opportunities related to digital technologies.

## ABOUT THIS UNIT

**This unit equips you with the knowledge and skills to critically engage with data, evidence, and intelligence related to financial crime and compliance.**

You'll explore how to evaluate the credibility and robustness of research findings and how to use them to inform evidence-based business strategies and policies.

You'll learn how to design and assess empirical research projects, interpret social scientific data, and evaluate whether compliance policies are effective in practice. The unit bridges the gap between academic research and professional practice, enabling you to make informed decisions and contribute to evidence-led governance within your organisation.

Topics include identifying intelligence gaps, intensive and extensive research methods, big data analysis, and designing your own research project.

## LEARNING OUTCOMES

- + Possess enhanced knowledge of evidence-based research in financial crime and compliance.
- + Formulate original research questions and design projects to support strategic decision-making.
- + Critically evaluate data and findings from social research, policy, and practice.
- + Confidently engage with stakeholders on prevention and intervention strategies in financial crime and compliance.

# OPTION 1: LONG DISSERTATION (60 CREDITS)

## ABOUT THIS UNIT

**This unit offers you the opportunity to undertake a substantial piece of independent research in the field of financial crime and compliance.**

Building on the theoretical and methodological foundations developed throughout the programme, you'll apply your knowledge to a focused research project of your own design.

Students selecting this option will complete a traditional dissertation of 10,000–12,000 words, typically based on original empirical research. You'll receive one-to-one supervision from an academic expert and are encouraged to develop your dissertation from the research proposal created in Unit 3.

This pathway is ideal for those seeking to deepen their expertise or pursue further academic research.

**Note:** This option requires approval from the Programme Director.

## LEARNING OUTCOMES

- + Critically engage with a specialist area of financial crime and compliance.
- + Identify research gaps, formulate questions, and design a research strategy.
- + Apply relevant theories and concepts to original research.
- + Manage and coordinate a research project independently or as part of a team.

# OPTION 2: SHORT DISSERTATION (60 CREDITS)

## ABOUT THIS UNIT

**This unit offers an alternative dissertation pathway for students who prefer a structured, literature-based research project.**

Instead of conducting original empirical research, you'll complete a 6,000–8,000-word extended essay that explores a specific issue in financial crime or compliance through a systematic review of the literature.

To support this, you'll also complete two 10-credit Research Skills in Practice modules: Critical Appraisal of the Literature, and Your Responsibilities as a Researcher. These modules provide foundational research skills and are tailored to the financial crime and compliance context.

This pathway is ideal for students at an earlier stage of research development or those seeking a more guided approach to independent study.

## LEARNING OUTCOMES

- + Critically engage with a focused topic relevant to financial crime and compliance.
- + Integrate advanced criminological and social scientific theory into your analysis.
- + Apply systematic review methods to develop a comprehensive understanding of your chosen topic.
- + Manage a research project that generates robust insights into a specific issue.

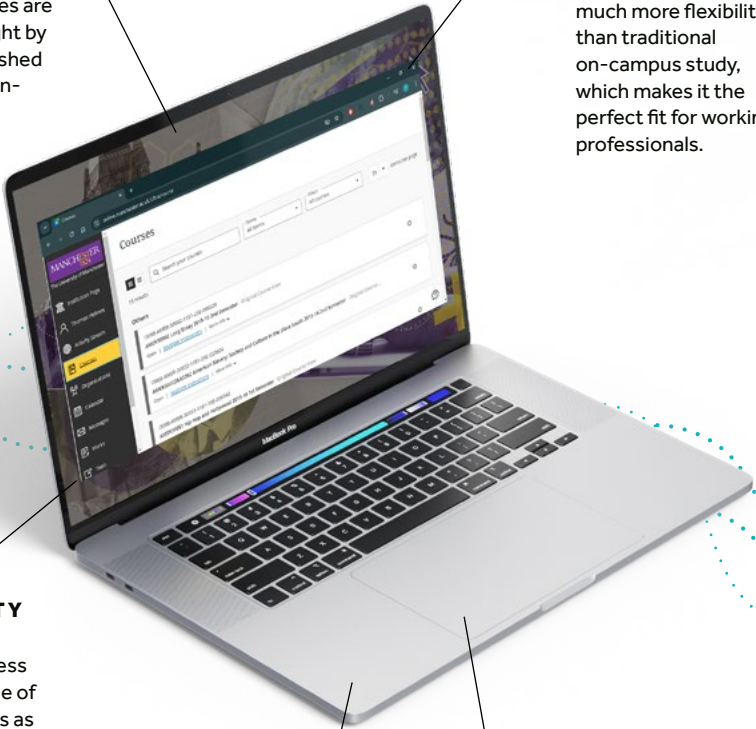

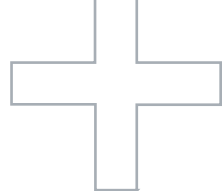

# NADIM'S STORY

**Nadim Awad, Senior Director of Compliance Investigations at Hikma Pharmaceuticals, oversees internal investigations across the Middle East, Europe, and the USA.**

With a career deeply rooted in enterprise risk management and regulatory compliance, Nadim wanted a program that would not only enhance his expertise but also offer practical insights applicable across industries. Having completed both the diploma and a professional postgraduate diploma, Nadim saw this master's program as a natural progression.

"Let's think about this one like an added value for me from a practical point of view," Nadim shared. "It's not just academic—it's about checking whether what I'm doing inside my company is aligned with best practices across the industry."

Nadim found the course's interdisciplinary and flexible design allowed him to tailor the material to his own professional needs. He also appreciated the diversity of his cohort, which included professionals from finance, real estate, insurance, and law.

"The nice thing about this degree is that it's comprehensive. It can be manipulated and changed according to the practice you are following,"

he explained. "That way, I can add to my day-to-day practice."

Nadim found the course structure, with its blend of academic rigor and practical application, extremely useful. The weekly modules combine

reading materials with engaging video content, supported by masterclasses that deepen understanding of complex topics like dissertation development and digital risk management.

"The practical masterclass is an added value to fine-tune the whole process," Nadim noted. "Yes, I could do it online completely, but these interactions bring insights beyond the material itself."

He found that networking was a crucial benefit of the course. With classmates from around 16 different jurisdictions, Nadim found the exchange of global perspectives invaluable—especially given his responsibility for compliance across multiple regions.

"It's good to know what's going on in terms of updates and best practices in these jurisdictions," he said. "Even outside the pharmaceutical industry, the insights from finance and legal sectors are extremely useful."

Time management is crucial, especially for professionals balancing work and family. Nadim emphasized the importance of staying on pace with the course:

"Don't leave it to the last moment like we used to do when we were young," he advised. "The standards here are very high, and to meet them, you need to manage your time not just properly—but perfectly."
